Total tax-only receipts were \$626.8 million for November 2021 which was \$18.9 million or 3.1% above the newly revised estimate and \$70.0 million or 12.6% above November 2020 receipts. See Attachment A. The performances of the four major tax sources which account for 94% of total tax-only receipts are summarized as follows:

- individual income tax receipts at \$288.9 million were \$4.6 million below the estimate, but \$13.5 million or 4.9% above November 2020; withholding tax receipts continue to remain stable during the pandemic.
- corporate income tax receipts were \$5.4 million or 64.1% above the estimate of \$8.4 million and \$8.5 million or 165.5% above November 2020; corporate income tax estimated payments are up suggesting that corporations expect to have a profitable 2021; the Bureau of Economic Analysis of the United States Department of Commerce reports that the 2<sup>nd</sup> and 3<sup>rd</sup> Quarters of 2021 were the most profitable ever.
- retail sales tax at \$223.6 million was \$6.6 million or 3.0% above the estimate and \$21.9 million or 10.9% above November 2020 receipts; this was the eighth month in a row where such receipts topped \$220.0 million.
- compensating use tax receipts at \$61.8 million were \$1.9 million or 3.2% above the estimate and \$12.6 million or 25.7% above November 2021; the enhanced receipts are in part attributable to collections from marketplace facilitators estimated to be in the range of \$7.5-8.0 million; SGF receipts from marketplace facilitators for July-October were \$31.2 million. The original fiscal note for the marketplace facilitator provision was \$35.5 million for all of FY 2022.
